## A call to action:

- 1. The Feminist/WROs should join the FHN National Humanitarian Platform hosted by CEPADWN in Uganda to have amplified voices, engage in collective action, share experiences and, coordinate efforts to address the complex and interconnected challenges facing women and girls in Uganda.
- Invest in Innovative Approaches to Social Protection: Governments, civil society organizations, and the private sector should invest in innovative approaches to social protection that empower women, such as mobile money transfers, vocational training, and digital literacy programs.
- 3. Provide Tailored Support and Services: Social protection programs should be tailored to address the specific needs and challenges of women, providing them with access to education, healthcare, and economic opportunities. This includes providing support for women with address their specific needs and challenges and this can work better if the WROs take the lead.

WROs have employed and demonstrated the impact of using innovative approaches to social protection which are essential for empowering women in Uganda because they recognize and live the unique experiences and challenges of women and are better placed to provide tailored support to address these specific needs.

We applaud several Women Rights Organizations in Uganda using innovative approaches to social protection to empower women such as Uganda Women's Effort to Save Orphans (UWESO), National Association of Women's Organizations in

Uganda (NAWOU), and Women's Economic Empowerment Project (WEEP) among many that use digital literacy, skilling, sponsorships, financial inclusion programs to provide women with the skills and knowledge they need to navigate the digital world, access information, and improve their economic well-being.

Empowering women through innovative approaches to social protection is critical for achieving inclusive and sustainable development disabilities, women in rural areas, and women who are survivors of violence.

- 5. Promote/Enhance Digital Literacy:

  promoted to provide women with the skills and
  knowledge they need to navigate the digital world,
  access information, and improve their economic
  well-being.
- 6. Address the Root Causes of Poverty: Social protection programs should address the root causes of poverty, including lack of education, limited access to healthcare, and unemployment.
- 7. Involve Men in Empowering Women: Men should be involved in empowering women, recognizing the critical role they play in promoting gender equality and challenging patriarchal norms that are still deep rooted particularly in our rural communities.
